On or about January 26, 2021, the City became aware that it needed the professional services of an engineering firm in order to prepare for the submission of various grants to the State, Lehigh Valley

Planning Commission and Federal programs. The submission window for the application of said grants is from June 2021 through July 2021. On or about January 26, 2021, the City obtained its first quote from McMahon Associates and on or about April 21, 2021 the City, in order to comply with the informal quote thresholds, contacted a second Contractor, Civitas Regio, in order to obtain a quote, of which they respectfully declined and submitted a "No Bid". Therefore, at this time, the City is seeking Council's approval for the contract with McMahon Associates.
