- 1. A-67827 602-604, 606 & 608-610 Hamilton & 10-12 & 14-16 S. 6TH St. Special Use Appeal of City Center Investment Corp. to DEMOLISH EXISTING BUILDINGS, CONSOLIDATE PROPERTIES & CONSTRUCT MULTI-STORY RETAIL & OFFICE BUILDING, with demolition permitted by Special Exception under Article 1314.03, located in a Central Business (B-2), Historic Building Demolition Overlay (HBDO), Hamilton Street Overlay (HSO) & Traditional Neighborhood Development Overlay (TNDO) District.
- 2. A-67881 101-103 West Susquehanna St. Special Use Appeal of Piyush Joshi & Harsha Joshi to convert first floor tattoo shop into a 1-BEDROOM DWELLING UNIT, (for a total of 4 dwelling units), & CONSTRUCT OPEN PORCH ROOF, (4 ft. x 3.58 ft.) with 1-STORY ADDITION, (4 ft. x 8.33 ft.), both at rear, with conversion of an existing lawful principal business use into 1 dwelling unit being permitted by Special Exception under Article 1313.01A.,& being a change of use granted by the Zoning Hearing Board under Application No. 64998 on March 26, 2013, & having insuff. lot area for additional dwelling, (4,000 additional sq. ft. req.; 0 proposed) & rear addition being an expansion of a nonconforming structure with insuff. 2nd front yard setback, (15 ft. req.; 1.33 ft. proposed), located in a Medium Density Residential District.
- **3.** <u>A-67927</u> <u>1210 North Van Buren St.</u> Appeal of Bruce Montgomery for variance to CONSTRUCT 1-STORY ENCLOSED PORCH (5 ft. x 10 ft.), at front, having insuff. front yard setback (24 ft. front yard averaging existing; 20 ft. proposed), located in a Low Density Residential (R-L) District.
