- Case Number HDC 2017-00004 Address: 36 N. 11th Street Proposal: remove brick coat; restore, repair, replace brick if damaged; replace front entry door; install porch light; remove aluminum siding from roof, install appropriate shingles; woodwork scraped, repaired, replaced if necessary and paint; replace windows.
- 3. Case Number HDC 2017-00005 Address: 433 ½ N. Howard Street Proposal: remove aluminum siding; remove paint from brick; repair, replace, repoint brick as needed; replace windows, currently 1 over 1 vinyl, owner requests 2 over 2 wood aluminum clad; replace front entry door; remove aluminum siding from dormer, repair and paint; replace porch light; make door awning historically appropriate; remove siding, install slate shingle roof; install historical iron grate on coal window; paint trim.

Case Number HDC 2017-00006 Address: 417 N. 6th Street Proposal: Remove stone coat; restore, replace, repoint brick as needed; replace front entry door; re-open transom window and replace baker's alley door; window replacement; concrete pad removed and replaced with stone step or brick & bluestone; add coal bin iron grate; dormer repair if needed; install porch light; add full glass storm door; replace trim where needed and paint trim.
- Proposed HUD funded demolition Address: 509 N 7th Street Contributing resource in the Allentown City Historic District. District is eligible for listing on the National Register of Historic Places
