a. "Advise the Mayor and Council and make recommendations on issues related to the homeless and near homeless populations in the City."

b. The Board shall serve as an advisory body. It shall be tasked with offering recommendations and suggestions on the following:

- i. Educating the public about homelessness and ways in which we can help people in need.
- ii. Providing policy-based advocacy on behalf of the homeless to appropriate agencies.
- iii. Making recommendations aimed at ending and preventing homelessness.

iv. Facilitating communications, networking and referrals within the community to deal with the issues of homelessness.

v. Providing a representation or a "voice" for homeless in the community.

vi. Seeking to ensure the immediate needs of those experiencing homelessness are met and their civil rights are respected and protected.

- c. Overall, "a Policy, Planning & Coordinating Commission, not a Provider"

- III. Reporting Requirements
 - a. Provide an Annual Report to the Mayor & City Council

i. The annual report should include a written report of the year's activities and a one-year plan and long-term goals;

b. The report should be presented to City Council no later than the second meeting in March.
