## ALL APPELLANTS MUST APPEAR AT MEETING

**1.** <u>A-71353</u> <u>402 Basin St</u> Appeal of Serfass Development & Acquisitions I, LLC for variance to CONSTRUCT 1-STORY 130,007 SQ FT WAREHOUSE with access drive, parking and truck dock facilities, exceeding maximum allowable steep slope disturbance in areas of 25-35% slope (25% permitted; 39.96% proposed) and areas over 35% slope, (0% permitted; 38.85% proposed), located in a General Industrial (I-3) District.

**2.** <u>A-71389</u> <u>2027-2029 Tilghman St</u> Appeal of Cuzins Pub & Grill for variance to ADD 28 SEATS FOR SEASONAL OUTDOOR SEATING, being an expansion of a non-conforming use, being a use denied by the Zoning Hearing Board under Application No. 47634 on September 17, 1990, having insuff. off-street parking (7 add'l spaces req; 0 add'l proposed), with proposed outdoor seating areas encroaching into the public right-of-way, located in a Medium Density Residential (R-M) District.

**3.** <u>A-71426</u> <u>11-13 S Dauphin St.</u> Appeal of Elias Issam for Margaret Baurkot Celerier for a variance to use vacant warehouse for WAREHOUSING AND DISTRIBUTION, with use not permitted under Article 1313.01.C, being a change of use granted by the Zoning Hearing Board under Application No. 55852 on August 20, 2001, located in a Medium High Density Residential (R-MH) District.
