AN ORDINANCE

Amending the 2021 General Fund Budget to provide for a supplemental appropriation of One Hundred Nineteen Thousand Seven Hundred Ninety-Three Dollars and Sixty-Nine Cents. (\$119,793.69) from the unappropriated balance of the 2021 General Fund to the 2021 Capital Fund as required by Trexler Trust Agreement.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund in the amount of One Hundred Nineteen Thousand Seven Hundred Ninety-Three Dollars and Sixty-Nine Cents (\$119,793.69) as follows:

Move funds from the unappropriated balance of the City General Fund and place those funds in the Valania Park capital project. A total of \$25,000.00 needs to be appropriated into the Capital account in order to build new park features at Valania Park. This is the City's 6% contribution requirement of the Trexler Trust.

Also, move funds from the unappropriated balance of the City General Fund and place those funds in the Jordan Creek Greenway Trail capital project. A total of \$94,793.69 needs to be appropriated into the Capital account to construct the trail. This is the City's 6% contribution requirement of the Trexler Trust
