Authorization for Contract with Wood Environmental and Infrastructure Solutions, Inc., not to exceed, \$474,945 to assist with a wide range of Stormwater Management Program support services to ensure compliance with, and develop required program components of, its Phase I, MS4 National Pollutant Discharge Elimination System permit, competitively bid, multiple vendors, 3 year contract, could be extended for two one year agreements.

WHEREAS, Article 130.16 of the City's Administrative Code requires City Council approval by Resolution for the award of contracts or engagement of professional services.

WHEREAS, it is the desire of the City of Allentown to enter into an agreement with the aforementioned Contractor, for the use and purpose indicated in supporting the Recommendation of Award of Bid:

Contract Consideration: The annual estimated total for this contract, is on an as needed basis and shall not exceed the sum of \$158,315.00 per contract year, for a total estimated initial contract term sum of \$474,945.00.

Description of project or scope of services to be provided:

On October 22, 2021, the City advertised a solicitation in order to obtain the services of a qualified consultant to assist with a wide range of Stormwater Management Program support services to ensure compliance with, and develop required program components of, its Phase I, MS4 National Pollutant Discharge Elimination System permit. On November 19, 2021, the City held the Public Opening for which it received four (4) proposals. The technical evaluation was held on November 22, 2021. All committee members were present. The Proposal submitted by Pennoni was disqualified due to firm making changes to the Indemnification clause on our RFP document. The Proposals were scored based on the RFP requirements, Ability to Meet RFP Requirements (30 Points), Prior Experience and Reputation w/ Similar Projects (25 Points), Qualifications/ Experience (30 Points). At the end of the review and scoring Wood Environment held the highest score. Cost proposals were opened on November 22, 2021, 3:00 PM. Proposals were distributed to all committee members via Microsoft Teams for evaluation after the completion of the technical evaluation. The cost evaluation committee meeting occurred on November 23, 2021, 2:00 PM. All committee members were present. After discussion the committee members scored the Proposals based on Cost (15 Points). The Committee made the recommendation to not proceed with Oral interviews/Presentations as they felt confident in deciding with the information provided in the Technical and Cost Proposals. The committee will award to the highest scored firm based on the final scores after the Oral interviews/Presentations. At this time the City recommends award to Wood Environment and Infrastructure Solutions.

Contract Term:

The Contract term shall commence upon full execution and shall cease three (3) years thereafter.

List any renewal term options and duration of each renewal, if any:

Upon mutual written agreement, this contract may be extended for up to two (2) additional one (1) year terms

 Maximum dollar value of all renewals provided for beyond the original term as if all renewals were exercised:

For each renewal year, there shall be a 3% increase.

A vote of final approval is requested of the members of Council and by passing the accompanying resolution, this Contract will be deemed approved and awarded.
