# AN ORDINANCE

Amending the 2022 General Fund by restructuring the Mayor's Office in accordance with the new administration's request.

# BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That page 23 of the General Fund budget be amended by adding one (1) Chief Operating Officer (21N) at an annual salary of One Hundred Twenty Thousand (\$120,000) Dollars.

SECTION TWO: That page 23 of the General Fund budget be amended by adding one (1) Project Manager (11N) at an annual salary of Sixty-One Thousand Nine Hundred Thirty (\$61,930) Dollars.

SECTION THREE: That page 23 of the General Fund budget be amended by adding one (1) Executive Assistant to the Mayor (11N) at an annual salary of Sixty-Five Thousand One Hundred Two (\$65,102) Dollars and eliminating the position of Executive Secretary to the Mayor (11N) at an annual salary of (Sixty-Four Thousand Seven Hundred Sixty-Six (\$64,766) Dollars.

SECTION FOUR: That page 23 of the General Fund budget be amended by adding one (1) Special Assistant (7N) at an annual salary of Fifty-Two Thousand Sixty-Three (\$52,063) Dollars and eliminating the position of Administrative Assistant (7N) at an annual salary of Fifty-Two Thousand Four Hundred Sixty-Eight (\$52,468) Dollars.

SECTION FIVE: That page 23 of the General Fund budget be amended by changing the salary of the Communications Manager (14N) current budgeted at an annual salary of Seventy-Five Four Hundred (\$75,400) Dollars to Seventy-Two Thousand Five Hundred Sixty-Six (\$72,566) Dollars. A savings of Two Thousand Eight Hundred Thirty-Four (\$2,834) Dollars.

SECTION SIX: That page 23 of the General Fund budget be amended by adding one (1) Marketing and Social Media Manager (10N) at an annual salary of Fifty-Nine Thousand Three Hundred Five (\$59,305) Dollars. This position currently exists in the Department of Community and Economic Development; therefore, page 197 will be amended to eliminate the position and the annual budgeted salary of Forty-Nine Thousand One Hundred Sixty-Six (\$49,166) Dollars will be transferred to the Mayor's Office.

SECTION SEVEN: That City Council authorizes the transfer of Forty-Nine Thousand One Hundred Sixty-Six (\$49,166) Dollars in the following manner:

The request is for City Council's authorization to convey a 1,800 square foot portion of the City-owned property located at 821 West Hamilton Street (the "Parcel") to Da Vinci Science City, LLC ("Da Vinci") to be used by Da Vinci as the entrance way to its Science Center for the encouragement, demonstration, education, exhibition of science, technology, mathematics and similar fields of study and creativity for the young and adult residents of and visitors to the City.
