AN ORDINANCE

Providing for the vacation of Howe Street from the centerline of North Eighth Street to its West Terminus in the Fourth Ward of the City of Allentown:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION 1. That Howe Street from the centerline of North Eighth Street to its West Terminus in the Fourth Ward of the City of Allentown and is hereby vacated.

SECTION 2. That the City of Allentown reserves an easement over the vacated area for drainage and for passage of public utilities such as electricity, telephone, water, gas and the like, together with the right of entry thereon for repairs, construction and reconstruction of the drainage facilities and the utilities mentioned, without any liability for damages on the part of the City. Where any such easement is reserved, no construction, temporary or permanent, shall be made over or across the vacated street area without the approval of Council by ordinance.

SECTION 3. Subject to the provisions set forth in Ordinance No. 12245, passed April 6, 1977.

SECTION 4. That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.

The request is for City Council's authorization to convey a 1,800 square foot portion of the City- owned property located at 821 West Hamilton Street (the "Parcel") to Da Vinci Science City, LLC ("Da Vinci") to be used by Da Vinci as the entrance way to its Science Center for the encouragement, demonstration, education, exhibition of science, technology, mathematics and similar fields of study and creativity for the young and adult residents of and visitors to the City.

The City is using a HUD loan to assist with the design, property acquisition, construction and operation of the Science Center which Da Vinci will repay under a Subrecipient Agreement. The benefit is the increase tax revenue to the City.
