AN ORDINANCE

Establishing the 2021 American Rescue Plan Act (ARPA) Fund budget in the amount of Twenty-Eight Million Five Hundred Seventy-Four Thousand Two Hundred Forty Dollars (\$28,574,240). This amount represents the first distribution from United States Federal Government. The total to be received by the City of Allentown is Fifty-Seven Million Four Hundred Sixty-Three Thousand Five Hundred Fifty-Seven Dollars and Seventeen Cents (\$57,463,557.17).

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2021 ARPA Fund in the amount of Twenty-Eight Million Five Hundred Seventy-Four Thousand Two Hundred Forty Dollars (\$28,574,240) reflecting receipt of monies from the United States Federal Government

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the ARPA Fund as follows:

SECTION THREE: That City Council authorizes an increase to the unappropriated balance of the General Fund in the amount of One Million Six Hundred Thousand (\$1,600,000) Dollars reflecting receipt of funds from ARPA.

SECTION FOUR: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund as follows:

SECTION FIVE: That this Ordinance will take effect ten (10) days after final passage.

SECTION SIX: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.

Bill 89 AMENDMENT PASSED, 7 - 0

I move to amend Bill 89 by providing expenditures for the following capital and other projects noted in the first tranche, leave the remaining funds in the unrestricted ARPA assets, and authorize the administration to make the adjustments to the account allocations to reflect the approved expenditures.

The rationale for acting on the capital projects is inclusive of the following issues.

1. Increased cost of capital project – material, steel costs, are escalating, already noted that Fire Academy has gone up around 1/2million – which means the initial proposal from the administration is off already.
2. City has already secured some contractors that will move on if the city doesn't approve more funding.
3. Competition in this space is increasing.
4. Money for infrastructures save all taxpayers money going forward, we need to get the most bang for the buck.
5. All these programs were submitted by the administration in the first tranche. I think there is a need to examine the AEDC \$3m allocation a bit more.
6. The administration can come forward with future proposals – specifically the AEDC project and mobile health clinic process and council can evaluate the proposal in more detail at that time.
7. Provides us more opportunity to work on other allocations at a future date and not be forced to make decisions under the threat of needing to adopt the whole package at one time. We can look at the other categories and bring in experts and work with the administration on procedures for such spending. We are currently looking at the budget and can act on these other categories later when we have time.
8. Keep section 4 intact for revenue replacement, changing the dollar amount to \$1.6 M
9. Remove Section 3
10. Change section 5 to reflect a supplemental appropriation into capital, \$15,810,000 (includes increased amount for fire academy).
