AN ORDINANCE

Amending the 2022 Capital Fund Budget to provide for a transfer of One Hundred Nineteen Thousand Five Hundred and Two (\$119,502) Dollars from Capital Project 2005 – Jefferson Street Road Diet and Flasher to capital project 1225 Traffic Signals – Upgrade Various.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That the City Council authorizes a transfer in the amount of One Hundred Nineteen Thousand Five Hundred and Two (\$119,502) Dollars as follows:

Summary and Facts of the Bill

For Capital Account (2005 - Jefferson Street Road Diet & Flasher), the City did not receive funding for the Jefferson Street Road Diet as planned but did install the road flasher. The City match funds that are remaining can be transferred to a newly created Capital Account for the Hanover Avenue Traffic Improvement project. The project is for the design and includes Traffic Signal Adaptive improvement at 7 intersections on Hanover Avenue, installing a pedestrian flasher and ADA handicap ramp at Hanover Ave. and Linden St. The City received DCED Funding for Hanover Ave Traffic Signal Improvement Construction.

Why should Council unanimously support this bill?

This transfer will be used for the design of 7 intersections on Hanover Avenue for Traffic Signal Adaptive improvement, a pedestrian flasher and ADA handicap ramps at Hanover Ave. and Linden St. The Hanover Avenue and Linden Street intersection is one of the City's high crash area.
