AN ORDINANCE

Amending the 2022 Capital Fund Budget to provide for a supplemental appropriation of Six Hundred Ninety (\$ 690.00) Dollars from Hijinx Brewing Company toward the construction of Phase 2 of the Jordan Skatepark project.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2022 Capital Fund in the amount of Six Hundred Ninety (\$ 690.00) Dollars reflecting receipt of monies from Hijinx Brewing Company:

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the Capital Fund as follows:
