The cost of gasoline has increased significantly from the time the 2022 budget was approved until now. The City's average cost of among the three different types of gasoline we purchase if \$4.60/gallon. As a result, the amount originally budgeted for 2022 is no longer sufficient to finish the year.

It is estimated that an additional \$500,000 is needed to purchase fuel through the end of 2022.

Funds are being transferred from the unappropriated balance of the General Fund, as well as various accounts within the General Fund, Solid Waste, Stormwater and Rental Unit Licensing Fund.

There is enough funds available from the original budgeted amount to make purchases through the first half of August. Therefore, approval at the first meeting in August would allow us to appropriate the additional funds in time to continue refilling the fueling stations.

# • Why should Council unanimously support this bill?

Without these additional funds, the City would not be able to continue purchasing gasoline, City gas pumps would go dry and vehicles would not be able to operate.
