Introduced by the Administration on August 3, 2022

Authorizes Submission of a Formal Application to the Multimodal Transportation Fund for a Grant through the Commonwealth Financing Authority in the amount of Five Hundred and Fifty-Nine Thousand Dollars (\$559,000) to support installation of new streetlights.

Resolved by the Council of the City of Allentown, That

BE IT RESOLVED, that the City of Allentown, Lehigh County hereby requests a Multimodal Transportation DCED Grant of \$559,000 from the Commonwealth Financing Authority to support installation of new street lights along Martin Luther King Jr Drive from the 8th Street Bridge overpass to Union Street.

BE IT FURTHER RESOLVED, that the City of Allentown hereby designates Matt Tuerk, Mayor, and Seth O'Neill, Finance Director, as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth Financing Authority.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Allentown, hereby authorizes the City of Allentown to submit the application for Five Hundred and Fifty Nine Thousand Dollars (\$559,000) in Multimodal Transportation DCED Funds to the Commonwealth Financing Authority.
