RESOLUTION

Introduced by the Administration on September 7, 2022

Authorizes the Submission of the Formal Application to the Pennsylvania Office of the Budget for a Grant of One Million Dollars (\$1,000,000) to support the DaVinci Science Center Downtown Allentown Project.

Resolved by the Council of the City of Allentown, That

BE IT RESOLVED, that the City of Allentown, Lehigh County hereby requested a Redevelopment Assistance Capital Program grant for \$1,000,000 from the Pennsylvania Office of the Budget to fund the development of the DaVinci Science Center Downtown Allentown.

BE IT FURTHER RESOLVED, that the City of Allentown hereby designates Matthew Tuerk Mayor, and Seth O'Neill, Finance Director, as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Allentown, hereby authorizes the City of Allentown to submit and accept One Million Dollars (\$1,000,000) in Redevelopment Assistance Capital Program funds to the Commonwealth of Pennsylvania Office of the Budget.

The DaVinci Science Center, the Subgrantee, is submitting a formal application to the State Office of the Budget, for which the City will serve as the Grantee. The \$1,000,000 awarded in Redevelopment Assistance Capital Program (RACP) funds will support the DaVinci Science Center Downtown Allentown project.
