#### AN ORDINANCE

Amending the 2022 Capital Fund Budget to provide for an appropriation of Three Hundred Sixty Six Thousand (\$366,000.00) Dollars from LCA that the City has negotiated for the purpose of construction of ADA handicap ramps as well as milling and paving of streets under the City's Utility Paving Program.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2022 Capital Fund in the amount of Three Hundred Sixty Six Thousand (\$366,000.00) Dollars from LCA.
