Authorization for change order for a contract previously awarded with BL Companies in the amount of \$17,080 for additional design and preparation work for the Valania Park Project; the original contract was for \$ 119,450, the new total would be \$136,530.

WHEREAS, it is the desire of the City of Allentown to increase the contractual sum of the previously awarded agreement with the following named contractor/consultant, for the use and purpose indicated in supporting the Recommendation of Award or Contract dated August 12, 2019:

- 2. Project or Contract Reference: C27-000062/ BID No. 2019-07- Valania Park Renovations
- Description of Service(s) to be provided: The Contractor shall provide the services of designing and preparing the construction documents for the Valania Park Improvements Project. In addition to Grandstand Structural Design, Splash pad/Sanitary/ Stormwater Redesign, and Sew Facility Planning Module.

Description of project or scope of services to be provided and why is an increase needed:

On August 12, 2019, both parties mutually agreed and entered into an agreement for Contractor to provide the services of designing and preparing the construction documents for the Valania Park Improvements Project. Per the 1st amendment additions to this project are as follows: Grandstand Structural Design, Splash pad/Sanitary/ Stormwater Redesign, and Sew Facility Planning Module. At this time due to the amount of submittals and RFI's for the construction of the project, the allotment by BL Companies was less and this is to pay for the time it took and review all the submittals and RFI's. The cost for additional submittals was \$10,230 to date. If requested by us (City) to have BL assist with color and graphics and two site visits, additional submittals and RFI's that may be needed and to for the punchlist, it will be an additional \$6,850. This is needed to complete the construction project with Flyway.

The current contract term commenced upon the issuance of the Notice to Proceed, September 9, 2019 and shall cease upon the Contractor's performance and all services required under the contract.
