AN ORDINANCE

Amending Part I Administrative Legislation, Authorities, Boards and Commissions, Article XIV Commission on Homelessness by updating the language in Sections 12-75 through 12-77.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That Sections 12-75 through 12-77 be amended as follows:

Article XIV

Commission on Homelessness

§ 12-75 **Purpose**.

The purpose of the Commission to advise the Mayor and Council and to make recommendations on issues relating to the homeless and near-homeless populations those who are experiencing homelessness or near-homelessness in the City.

§ 12-76 Establishment and composition.

A. The Commission on Homelessness shall consist of 15 members appointed by the Mayor and approved by City Council. Members shall include representatives from government, nonprofits, faith-based organizations, hospitals and other stakeholders involved in advocacy and service for the homeless or near-homeless those who are experiencing homelessness or near-homelessness. The Mayor shall appoint the Chairperson of the Commission with the approval of Council. One member of Council shall serve as a nonvoting liaison. The Mayor shall designate staff support for the Commission.

§ 12-77 Powers and duties.

The Commission shall serve as an advisory body. It shall be tasked with offering recommendations and suggestions on the following:

- A. Educating the public about homelessness and ways in which we can help people in need.
- B. Providing policy-based advocacy on behalf of the homeless those who are experiencing

homelessness to appropriate agencies.

- C. Making recommendations aimed at ending and preventing homelessness.
- D. Facilitating communications, networking and referrals within the community to deal with the issues of homelessness.
- E. Providing a representation or a "voice" for homeless those who are experiencing homelessness in the community.

SECTION TWO: That this Ordinance takes effect ten (10) days after final passage.

SECTION THREE: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.
