AN ORDINANCE

Amending the 2023 General Fund budget to provide for a supplemental appropriation of One Hundred Thousand (\$100,000.00) Dollars from the Housing Fund for the use of the APA RFP, replacing a piece of aging equipment in the mail room & sundries in the CED-Admin program. These funds were previously encumbered for a CED community engagement program that now lives in the Mayor's office.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a supplemental appropriation of One Hundred Thousand (\$100,000.00) Dollars from the General Fund as follows:

PO# 225-104196 encumbered \$100,000 in the Housing Fund for a Community Engagement RFP. The Civic Innovations program (mayor's office) will be administering the engagement program in-house through the CHATT initiative at a reduced cost. The initial funding source of the housing fund was the General Fund. The savings from administering the program in-house will be used to pay for the APA RFP, replace a piece of aging equipment in the mail room & sundries in the CED-Admin program.

Transfers previously encumbered funds from the Housing Fund intended for an outside vendor to support community engagement back to the initial source (General Fund) to allow the community engagement initiative to be managed in-house. Administering the program in-house reduces cost. This General Fund savings will be used to replace a piece of aging equipment in the mail room for processing mail leading to increased efficiency in 2023.

Administering the Community Engagement program in-house reduces cost and allows for greater flexibility and oversight.

Replacing the aging mail room equipment increases efficiency within the department and provides continuity of services to the City departments.
