## AN ORDINANCE

Amending the 2023 General Fund budget to allow for the Maintenance Mechanic Specialist position currently budgeted in the Trexler Fund to move to the General Fund Parks and Recreation Department. This will help to balance the Trexler Fund budget for the year 2023.

### BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That page 225 of the Trexler Fund budget be amended by deleting one (1) position below:

# **Maintenance Mechanic - Specialist**

SECTION TWO: That page 163 of the Parks and Recreation budget be amended by adding one (1) position below:

### Maintenance Mechanic - Specialist

SECTION THREE: That this Ordinance will take effect ten (10) days after final passage.

SECTION FOUR: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.

#### Legislative Template

What department or bureau is this bill originating from? Where did the initiative for the bill originate?

The Trexler Trust fund has awarded an amount lower than the amount that was estimated and budgeted for the Trexler Fiscal Year 2023 - 2024. Parks and Recreation would like to move the Maintenance Mechanic Specialist position from the Trexler Fund and place it in the General Fund to help assist in balancing the Trexler Fund budget for 2023.

Summary and facts of the bill.

Move the Maintenance Mechanic - Specialist position, which is currently funded 100% by the Trexler fund, and change the position to 100% funded in the general fund.

Changing the funding source for the Maintenance Mechanic - Specialist position will assist the Department in balancing the Trexler fund budget for 2023.

This is a total of \$38,974.80 transferring from the Trexler fund to the General Fund Parks and Recreation Department.
