AN ORDINANCE

Amending the 2023 General Fund budget ~~to accommodate two title changes and a reorganization of positions to allow the Mayor's office to operate more efficiently and prepare for future project work. The General Fund budget will be amended~~ by changing the titles of the Grants Coordination Manager (14N) ~~to Manager of Strategic Initiatives (14N) and the Executive Assistant (11N) to Grants Coordinator (11N).~~

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That page 23 of the General Fund budget be amended by changing the titles of the Grants Coordination Manager (14N) ~~to Manager of Strategic Initiatives (14N) and the Executive Assistant (11N)~~ to Grants Coordinator (11N).

SECTION TWO: That this Ordinance will take effect ten (10) days after final passage.

SECTION THREE: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.

- What department or bureau is this bill originating from? Where did the initiative for the bill originate?

The Mayor's office

This ordinance would change the title of Grants Coordination Manager (S13) to Manager of Strategic Initiatives at the same step. It would also change the title of Executive Assistant (S11) to Grants Coordinator at the same step. The Grants Coordinator position will report to the Manager of Strategic Initiatives.

This is a small reorganization in the Mayor's office to help manage and prioritize the needs of the City and the Mayor.
