AN ORDINANCE

Amending the 2016 General Fund Budget to provide for a supplemental appropriation of Fifty (\$50) Dollars as a result of a donation from Rebecca Robertson to be used toward the purchase of a Reeves Stretcher by Emergency Medical Services.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2016 General Fund in the amount of Fifty (\$50) Dollars reflecting receipt of a donation from Rebecca Robertson toward the purchase of a Reeves stretcher.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund in the following manner:

SECTION THREE: That this Ordinance will take effect ten (10) days after final passage.

SECTION FOUR: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.
