Authorization for Engagement of Professional Services with Community Bike Works in the amount of \$2,500.00 to increase the safety and skills of area cyclists through formal, certified instruction, with an additional benefit of increased physical activity and fitness

On behalf of the Administration, pursuant to City Ordinances, Article 130.16, I request City Council's approval of the following recommendation of the referenced contract award or price increase.

- Check Type of Contract or Change:

The contract is for over \$40,000 and required to be competitively bid under the City Code. We have advertised the above referenced project and received qualified bids/proposals. We recommend award of the contract to the bidder/proposer identified and for the reasons stated below.

The recommendation is for a price increase of 10% or more for an existing contract over \$40,000 that was previously bid and awarded under city policies.

x The engagement of professional services. We have received and reviewed a proposal or proposals for professional services in connection with above referenced project or requirement for professional services. We recommend award of the engagement.

January 1, 2017 – June 30, 2017

- Description of project or scope of services to be provided:

- 1) Youth and adult bicycle education via the certification of Community Bike Works staff as League Cycling Instructors (LCI) and as a result, the training of 8 – 12 students by the LCI on 6 Saturday bike rides that focus on bicycle riding skills, bicycle safety, and exposure to various riding environments. Six students will work with staff members to learn how to inspect bicycle and basic repairs. A focus on importance of wearing and fitting helmets will be included. Youth involvement in bike inspections will promote a positive bike culture among Allentown youth.

- State the actual or estimated price to the City or the proposed Department budget allowance for the initial term; and state payment rate per unit of service if applicable:

April 2017 – 3 staff training for 24 hours each = \$1,440

April 1 – June 30, 2017 – payment for 3 staff @ 20 hours = \$1,060 (six Saturday lessons/rides)
