Storm Sewer Fittings shall be purchased at the unit prices identified in the attached bid tabulation. The City budgets funds under the Public Works Department to cover the costs of the fittings. Based on estimated quantities provided during the bidding process, the annual estimated budgeted amount for the items is \$87,395.00. This is the total cost allocated for the LVCPC members. The quantities provided in the bid are estimates, and as such, the actual cost of the fittings may vary throughout the year based on the needs of the department.

The City reserves the right to extend this contract for up to three (3) months. This extension will be utilized only to prevent a lapse on contract coverage, and only for the time necessary, up to three (3) months to issue a new contract.
