Submission of a Redevelopment Assistance Capital Grant for Cedar Crest College Athletic Field Renovations

Resolved by the Council of the City of Allentown, That

WHEREAS, Pennsylvania Governor Tom Wolf authorized the release of One Million Dollars, (\$1,000,000.00) in Redevelopment Assistance Capital Grant Funding for the purpose of a pass through grant to the City of Allentown to provide funds for the renovation of the athletic fields at Cedar Crest College in Allentown; and

WHEREAS, the City of Allentown will serve as the grantee and the project administrator of these funds; and Cedar Crest College will serve as the sub-grantee and the actual recipient of these funds.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Allentown, hereby authorizes the City of Allentown to submit the application for One Million Dollars, (\$1,000,000.00) in Redevelopment Assistance Capital Grant Funding to the Commonwealth of Pennsylvania.
