AN ORDINANCE

Amending the 2017 Grant Fund Budget to provide for a supplemental appropriation of One Million Dollars (\$1,000,000.00) from the Commonwealth of Pennsylvania Office of The Budget, Redevelopment Capital Assistance Project to the City of Allentown as a pass through grant to Cedar Crest College for the Athletic Field Renovations project.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2017 Grant Fund in the amount of One Million Dollars (\$15,000.00) reflecting receipt of monies from the Commonwealth of Pennsylvania Office of The Budget, Redevelopment Capital Assistance Project.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the Grant Fund as follows:

SECTION THREE: That this Ordinance will take effect ten (10) days after final passage.

SECTION FOUR: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.

Purpose of the ordinance is to appropriate the revenue and expenses for the RACP pass-through grant for the Cedar Crest College Athletic Field Renovations project.
