## Resolved by the Council of the City of Allentown, That

**WHEREAS**, Article 130.16 of the City's Administrative Code requires City Council approval by Resolution for the award of contracts or engagement of professional services.

**WHEREAS**, it is the desire of the City of Allentown to enter into an agreement/engage the services of the following named contractor/consultant, for the use and purpose indicated in supporting the Recommendation of Award of Bid or Contract dated March 17, 2017:

Estimated Price: \$7,500. This a unit price agreement. Actual costs will be based on the number of tests conducted throughout the year.

Automatic renewal for additional one year periods.

\$7,500.00 annual (estimated)

The City plans to use drug and alcohol testing from multiple providers, St. Luke's and LVHN, depending on the particular needs of the City, that in the administration's view provided the best result for the cost of the service.
