HISTORY OF THE PORTION OF THE STREET PROPOSED TO BE VACATED:

The portion of street proposed to be vacated is in the 15th Ward. E. Nevo Street was created by the Subdivision Plan of "Allen-Beth Terrace Property of Joseph F. Gorman" approved by the City of Allentown on July 28th, 1920.

LOCATION AND CONDITION:

The subject street to be vacated was proposed to have a twenty foot right-of-way. The street has been unopened for over 21 years and the City has lost any legal interest within the right-of-way. The western 400 feet consist of lawn and wooded area. The Eastern 140 feet is a paved parking area. There are existing Private deeded easements for Sanitary Sewer lines within the subject area.




