### Introduced by the Administration on May 17, 2017

Authorization for Greenways, Trails, and Recreation Program (GTRP) grant of \$250,000 from the Department of Community and Economic Development to be used for MLK Parkway Trail planning project.

#### Resolved by the Council of the City of Allentown, That

**BE IT RESOLVED**, that the City of Allentown of Lehigh County hereby request a Greenways, Trails, and Recreation Program (GTRP) grant of \$250,000 from the Pennsylvania Department of Community and Economic Development to be used for MLK Parkway Trail Planning Project.

**BE IT FURTHER RESOLVED**, that the Applicant does hereby designate Ed Pawlowski, Mayor as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.
