HISTORY OF THE PORTION OF THE STREET PROPOSED TO BE VACATED:

The portion of North Lawn Street proposed to be vacated is in the 17th Ward. North Lawn Street was created by the Allentown Land Co. #2 Subdivision Plan, Dated January, 1929. If the street vacation is granted, it appears that the affected right-of-way would revert to each Adjoining property owner. It is the responsibility of the affected adjoining property to assimilate vacated property into fee simple ownership by deed.
