HISTORY OF THE PORTION OF THE STREET PROPOSED TO BE VACATED:

The portion of street proposed to be vacated is in the 14th Ward. N. Folk Street was created by the Subdivision Plan of "East Allentown Land Association Property of Alfred J. Clader" laid out in 1903 as part of Hanover Township and was known as Spruce Street. The City annexed this portion of Hanover Township and accepted the existing street system on December 1st, 1911. On April 26th, 1920 by Ordinance No. 1057 City Council renamed Spruce Street to N. Folk Street.

LOCATION AND CONDITION:

The subject street to be vacated has a twenty foot right-of-way. The street is opened and improved with paving and stone surface. If the subject street vacation is granted, the underling owners could assimilate the vacated property into fee simple ownership by deed.







Allentown, Pennsylvania Street View - Jul 2015




