AN ORDINANCE

Amending the 2017 Capital Fund and the 2017 General Fund to provide for a transfer in the amount of One Hundred Forty-One Thousand Dollars (\$141,000) from the Capital Fund Project Blight Removal and Remediation to the Planning Program of the General Fund for the in-take and community outreach of the Upside Allentown Housing Rehabilitation Program.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a transfer from the 2017 Capital Fund in the following manner:

- **Summary and Facts of the Bill**

The purpose of this ordinance is to move funds originally appropriated in the Capital Fund through the Water/Sewer Lease proceeds for blight removal and remediation to the General Fund to pay for the in-take and community outreach for the Upside Allentown program.

This type of professional service is not a capital expenditure therefore the funds need to be transferred from the Capital Fund where there were originally appropriated into the General Fund.

The \$141,000 is part of the \$600,000 that was appropriated into Capital Program 2400 for Blight Removal and Remediation. The full amount of \$600,000 originated from the proceeds of the Water/Sewer Lease.
