AN ORDINANCE

Amending the 2017 General Fund budget by adding a total of two positions in the Bureau of Building Standards and Safety: Housing Inspector (14M, Step D) and Rehabilitation Specialist (14M, Step D). Each position is budgeted at an annual salary of Forty-Nine Thousand Three Hundred Twenty-Seven Dollars (\$49,327) and funded through the CDBG Program.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That page 258 be amended by adding two positions in the Department of Community and Economic Development, Bureau of Building Standards and Safety. One Housing Inspector (14M, Step D) and one Rehabilitation Specialist (14M, Step D). Each position being budgeted at an annual salary of Forty-Nine Thousand Three Hundred Twenty-Seven Dollars (\$49,327).

SECTION TWO: That City Council authorizes an increase to the unappropriated balance of the 2017 General Fund to reflect a reimbursement from the Community Development Block Grant to fully fund the two new positions in the Bureau of Building Standards and Safety in the amount of Sixty-Nine Thousand Four Hundred Forty (\$69,440) Dollars as follows:

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund for the remaining seventeen (17) pay periods for each of these positions totaling Sixty-Nine Thousand Four Hundred Forty (\$69,440) Dollars as follows:
