AN ORDINANCE

Amending the 2017 Health Budget to provide for a supplemental appropriation of Forty-Eight Thousand Seven Hundred (\$48,700) Dollars as a result of a grant from Highmark to provide for the continued training and support to help guide the Allentown Health Bureau in establishing a quality improvement and quality assurance plan to better serve the community and to meet the requirements necessary to reach public health accreditation.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2017 Grant Fund in the amount of Forty-Eight Thousand Seven Hundred (\$48,700.00) Dollars reflecting receipt of monies from Highmark, to provide for a consultant (Continual Impact LLC) to provide quality assessment, training, strategic annual improvement process planning, coaching and leadership training and community health improvement plan development.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund as follows:
