AN ORDINANCE

Amending article 507 (Traffic control Maps) of the Codified Ordinances of the City of Allentown.

The request is from the Administration. The Administration is authorized to establish traffic regulations for a temporary period of time not to exceed 90 days. This gives Traffic time to evaluate the impact of the change. This legislation, in effect, would make the changes permanent.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That pursuant to Section 507.02, changes in Maps by Ordinance authorizing amendments to the Traffic Control Maps of the City, the following traffic regulation is hereby made permanent.

BRICK & FURNACE STREET
NORTH EXIT OF 327 LINDEN ON BOTH SIDES OF AMER PKW

NO RIGHT TURN

FURNACE ST AT FRONT ST FOR SWC PARKING LOT AMERICAN PKWY NB AT LINDEN ST ON NE POLE 802 N FRONT STREET- ON FURNACE ST
