AN ORDINANCE

Amending the 2017 Capital Fund Budget by transferring available funds from Capital Project 1806 – Emergency Sewer Repairs and Capital Project 1743 – Mechanical Renovations Waste Water Plant to Capital Project 2201 – Pool and Spray Parks in the amount of Five Hundred Thousand (\$500,000.00) Dollars for the renovations to Cedar Beach Pool.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a transfer in the amount of Five Hundred Thousand (\$500,000.00) Dollars as follows:

Finance Department

This Bill transfers available funds from two completed capital projects to Project 2201 for pool construction.

The City has completed two capital projects funded by cash proceeds from the Sewer Fund prior to the 2013 concession lease to the Lehigh County Authority. Funds remain after project completion, and, as no ongoing commitment of the funds is required under terms of the concession lease, these funds may be directed to other general capital projects in the City. This bill authorizes a shift in appropriation authority to capital project 2201 to provide additional resources for anticipated expenditures therein.
