RESOLUTION

Introduced by the Administration on October 4, 2017

Authorizes submission of an Edward Byrne Memorial Justice Assistance Grant which may be used to provide equipment, supplies, contractual support, training, technical assistance, and information systems for criminal justice.

Resolved by the Council of the City of Allentown, That

WHEREAS, The Edward Byrne Memorial Justice Assistance Grant (JAG) Program is the primary provider of federal criminal justice funding to States and units of local government. BJA awards JAG program funds to eligible States under the FY 2017 JAG Program State Solicitation. Additionally, a separate solicitation is issued for applications to BJA directly from units of local government. The City of Allentown Police Department and the County of Lehigh has been allocated \$57,398. The funding may be used to provide equipment, supplies, contractual support, training, technical assistance, and information systems for criminal justice.

WHEREAS, The City of Allentown will serve as the grantee and recipient of the funds as well as the project administrator of these funds. The County of Lehigh will serve as the sub-grantee.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Allentown, hereby authorizes the City of Allentown Police Department to submit the application in the amount of \$57,398 to the Department of Justice.

The bill originated from the Police Department

• Summary and Facts of the Bill

This bill reflects a Department of Justice Grant 2017-H3472-PA-DJ for \$ 57,398 for the Allentown Police Department (\$39,420.00) and Lehigh County Regional Crime Center (\$17,978.00). The funds are to be used for the purchase of Kronos scheduling software to be utilized by the entire department and the County portion to purchase a drone to document crime scenes and accidents from an aerial point of view.
