AN ORDINANCE

Amending the 2017 Capital Fund Budget to provide for a supplemental appropriation of Twenty-Five Thousand Dollars (\$25,000) from the Pet Safe Bark for Your Park Project to the City of Allentown to assist with the construction of a dog park.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2017 Capital Fund in the amount of Twenty-Five Thousand Dollars (\$25,000.00) reflecting receipt of monies from the Pet Safe Bark for Your Park Project to the City of Allentown to assist with the construction of a dog park.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the Capital Fund as follows:
