#### AN ORDINANCE

Amending the 2017 Risk Management Fund Budget to provide for a supplemental appropriation of One Hundred Fifty-Six Thousand Eight Hundred Fifty-Eight Dollars and Forty-Nine Cents (\$156,858.49) from the CNA Insurance Company for reimbursement of damage at City Hall.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2017 Risk Management Fund in the amount of One Hundred Fifty-Six Thousand Eight Hundred Fifty-Eight Dollars and Forty-Nine Cents (\$156,858.49) from the CNA Insurance Company for reimbursement of damage at City Hall.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the Risk Management Fund as follows:
