Reason for Vacation of Street

The proposed street to be vacated has been unopened and never used as a right of way for more than 21yrs, therefore all public right to it has been lost.

The vacation will not adversely affect the street pattern because the abutting proposed cross street to the East (vacated S. Tenth Street) was never opened and has been vacated by ordinance no. 8310 since 12/27/66.

No public need will be adversely affected nor will the right of way be needed by the public in the future since it can never be opened as a through street because of the prior vacation of all connecting planed streets to the East.

No abutting property owner will become landlocked nor will he have his access substantially impaired because there is better and sufficient access to all abutting properties via existing public streets.
