Road Materials shall be purchased at the unit prices identified in the attached bid tabulation. The City budgets funds in the Streets Department Budget to cover the costs of the materials. Based on estimated quantities provided during the bidding process, the annual estimated budgeted amount for the streets materials awarded to these vendors are \$1,419,241.50. The quantities provided in the bid are estimates, and as such, the actual cost of the chemicals may vary throughout the year based on the needs of the department.
