On behalf of the Administration, pursuant to City Ordinances, Article 130.16, I request City Council's approval of the following recommendation of the referenced contract award or price increase.

The contract is for over \$40,000 and required to be competitively bid under the City Code. We have advertised the above referenced project and received qualified bids/proposals. We recommend award of the contract to the bidder/proposer identified and for the reasons stated below.

Prepare PennDOT's Multi-modal Transportation Fund technical grant application for traffic calming and safety to improve along the South Jefferson Street corridor in the City of Allentown.

- Reasons for recommendation of Administration and Council approval of contract:

Opportunity to leverage 70% funding for project through PennDOT's extremely competitive multimodal grant program. This application requires technical estimates and concept engineering. The Jefferson Street Corridor project is in anticipation of a substantial increase in vehicular and pedestrian usage. In addition to traffic calming features, a bike-share lane to promote access to Hamilton Street is also planned. This project will also address the lack of adequate street light illumination on this stretch of the project from Elm to Wyoming. In addition, the City will be keeping pace with its commitment to improve handicap ramps throughout the City.
