Introduced by the Administration on May 2, 2018

Authorization for Contract with Pine Run Construction in the amount of \$536,800.00 to obtain the services of a Pennsylvania Department of Environmental Protection (PADEP) Certified Contractor to remove or perform in-place closure services for the existing fueling station at the Municipal Garage. This project shall also include the removal or closure of two (2) 10,000 gallon underground storage tanks and replace with two (2) 15,000 gallon above ground double wall fireguard (or approved equal) storage tanks. All required Pennsylvania Department of Environmental Protection (PADEP) soils testing and closure documentation and reports shall be included in the contract cost for the removal/closure of the existing tanks – competitively bid, three bids.

WHEREAS, Article 130.16 of the City's Administrative Code requires City Council approval by Resolution for the award of contracts or engagement of professional services.

WHEREAS, it is the desire of the City of Allentown to enter into an agreement/engage the services of the following named contractor/consultant, for the use and purpose indicated in supporting the Recommendation of Award of Bid or Contract dated March 29, 2018:
