AN ORDINANCE

Amending the 2018 General Fund Budget to provide for a supplemental appropriation of Twelve Thousand (\$12,000) Dollars from the Pennsylvania Historical and Museum Commission (PHMC) to fund a Historical Preservation Specialist Consultant to assist the City's Historic Architectural Review Board (HARB).

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2018 General Fund in the amount of Twelve Thousand (\$12,000) Dollars reflecting receipt of monies from the PHMC to fund a Historical Reservation Specialist Consultant to assist with HARB.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund as follows:

Department of Community and Economic Development Bureau of Planning and Zoning

SECTION THREE: That this Ordinance will take effect ten (10) days after final passage.

SECTION FOUR: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.

Summary and Facts of the Bill

This is a request for a resolution to accept a grant in the amount of \$12,000 from the Pennsylvania Historical and Museum Commission / Pennsylvania State Historic Preservation Office (PA SHPO) to hire a professional historic preservation consultant to review applications for certificates of appropriateness (COA) for exterior alterations to buildings in the historic districts.

The bill allows the City to accept the grant in the amount of \$12,000 to hire a historic preservation consultant to review applications for COA's for alterations to buildings in the historic districts. This service will provide staff and the Historical Architectural Review Board (HARB) with expert advice on proposed alterations, based on the Design Guidelines for Historic Districts in Old Fairgrounds, Old Allentown and West Park. The City has been a Certified Local Government (CLG), which is a state and federal program that recognizes the value of the historic preservation program in the City of Allentown. Historic preservation is also a component in the current Comprehensive Plan.

Costs will be completely covered by the grant. Salaries of staff will be used to match the grant. This will help the City to continue to preserve historic architecture in the City.
