AN ORDINANCE

Amending the 2018 Capital Fund Budget by transferring Fifty Thousand Eighty Dollars and Forty-One Cents (\$50,080.41) within Capital Project 1805 – Emergency Water Repairs and transferring One Hundred Nineteen Thousand Four Hundred Twenty-Nine Dollars and Ninety-Nine Cents (\$119,429.99) from Capital Project 1743 - Mechanical Renovations Wastewater Plant and One Hundred Sixteen Thousand Six Hundred Sixty-Three Thousand (\$116,663.00) Dollars from Capital Project 1806 – Emergency Sewer Repairs to Capital Project 1805 – Emergency Water Repairs to reimburse the Lehigh County Authority a total of Two Hundred Eighty-Six Thousand One Hundred Seventy-Three Dollars and Forty Cents (\$286,173.40) for work they have completed.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN

SECTION ONE: That City Council authorizes a transfer within the 2018 Capital Fund in the amount of Two Hundred Eighty-Six Thousand One Hundred Seventy-Three Dollars and Forty Cents (\$286,173.40) as follows:

Summary and Facts of the Bill

This Bill transfers \$50,080.41 within Capital Project 1805 – Emergency Water Repairs and transfers \$119,429.99 from Capital Project 1743 - Mechanical Renovations Wastewater Plant and \$116,663.00 from Capital Project 1806 – Emergency Sewer Repairs to Capital Project 1805 – Emergency Water Repairs to reimburse the Lehigh County Authority a total of \$286,173.40 for work they have completed.

Capital Project 1805 – Emergency Water Repairs is one of the projects identified as uncompleted work which the City started but was unable completed prior to the 2013 Water/Sewer Lease Concession with Lehigh County Authority (LCA). The available funds with that Project simply need to be moved to the proper standard account for payment to LCA. The funds were originally budgeted in accounts applicable to City staff performing the work, but with the lease to LCA the proper standard account is 46 – Other Contract Services.

The transfer of funds from Capital Projects 1806 – Emergency Sewer Repairs and 1743 – Mechanical Renovations Wastewater Plant moves available funds from these completed projects to the Emergency Water Repair Project where they are needed for the continuation of valve replacements.
