This Bill corrects the original 2015 appropriation of a Redevelopment Assistance Capital Program (RACP) Grant for Sacred Heart Hospital

The RACP grant was awarded to the City as a pass-through to Sacred Heart Hospital in the amount of \$500,000; however, when the appropriation was made in the 2015 budget the State retainage was withheld and only \$487,500 was added to the Grant Fund. The project is now closed and the State has reimbursed the City the \$12,500 retainage which has increased the unappropriated balance and needs to be applied to the expenditure side to correct the negative balance caused by the grant not being budgeted originally for the full amount.
