• Description of project or scope of services to be provided:

High Environmental Health & Safety Consulting Ltd. is pleased to provide the City of Allentown with an Indoor Environmental Quality (IEQ) assessment in the Central Fire Station located at 723 West Chew Street, Allentown, Pennsylvania. The assessment was requested due occupant concerns of microbial and chemical impact, as a result of past water intrusion events and past building usage, and subsequent health concerns. The IEQ assessment included a visual inspection of accessible areas and mechanical ventilation system, and real-time monitoring for ambient data measurements and total volatile organic compounds (TVOCs). Up to 11 air samples and 6 surface samples will be analyzed for fungal spore identification and particulate characterization. Two samples (1 air and 1 surface) will be analyzed for Asbestos fibers. Two (8-hour) air samples for 61 specific VOCs will be analyzed. A detailed report of findings, comparisons to established guidelines, and recommendations, as pertinent, will be provided following receipt of all analytical results.
