AN ORDINANCE

Amending the 2018 Capital Fund Budget by transferring Fifteen Thousand (\$15,000) Dollars from Capital Project 1905 City Wide Park and Playground Improvement to Capital Project 2208 Auburn Cross Trails for the City's match to the Pennsylvania Department of Community and Economic Development grant for the planning phase of Auburn Cross Trails.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a transfer within the Capital Fund in the amount of Fifteen Thousand (\$15,000) Dollars as follows:
