Authorization for Engagement of Professional Services with Michael Baker, International in the amount of \$150,000 for consulting, planning and engineering services related to the completion of a master plan for land known as the Auburn Cross Trail Park – property owned by the City and the Allentown Commercial and Industrial Authority (ACIDA). The purpose is to complete the Act 2 Land Recycling Process for the property. It was competitive bid and there were 5 bids.

WHEREAS, Article 130.16 of the City's Administrative Code requires City Council approval by Resolution for the award of contracts or engagement of professional services.
