Resolved by the Council of the City of Allentown, That


BE IT RESOLVED, that the City of Allentown, Lehigh County hereby requests a FY2018 Municipal Assistance Grant of \$100,000.00 from the Pennsylvania Department of Community & Economic Development to support the development of a new City Comprehensive Plan.

BE IT FURTHER RESOLVED, that the City of Allentown hereby designates the Mayor and Finance Director as the official(s) to execute all documents and agreements between the City of Allentown and the Department of Community & Economic Development to facilitate and assist in obtaining the requested grant.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Allentown, hereby authorizes the City of Allentown to submit the application for One Hundred Thousand Dollars (\$100,000.00) in Municipal Assistance Grant funds to the Department of Community & Economic Development.

The City is submitting an application to the Municipal Assistance Program of the PA Department of Community & Economic Development. This application is a request for \$100,000 that will be matched dollar for dollar with budgeted city funds and in-kind salary. Funds will support the development of the City's Comprehensive Plan.

The grant request is for \$100,000. There is a 50/50 project match. The City has already budgeted \$150,000 toward the Comprehensive Plan project. Staff salaries are also an eligible match. Grant funds will be used to pay professional consultant fees.
